#### **Pre-Signing Steps 1-7**

Pre-signing steps that need to be done in advance prior to closing. These steps include reviewing the documents which could take up to 1-2 hours. Write your questions down to ask the notary during your closing appointment.

#### Step 1

You should receive an email from the Priority Title & Escrow. When you are ready, Click on the "**Review and Sign**" link.

Review the E-Sign Disclosure and Consent. This must be signed before reviewing your closing documents. Click on the "**Sign Now**" button at the top right-hand corner.

#### Step 6

After you sign the E-Sign consent form, Click on the "**Next Document**" button at the bottom right and review all the documents until it says "Complete" Once you click on "**Complete**" this step is finished and you are done with your pre-signing process. Proceed with setting up your Audio and Video to trouble shoot any issues in advance before closing.



#### Step 7

Set-up for Audio/Video/Internet Wi-fi check. Once this step is complete, there is **no need to proceed with ID validation until your scheduled appointment**. You will have to redo the ID verification the next time you log in to the system.



- a. Select your proper video device
- b. Select your audio device
- c. Check your internet connection (done automatically), If your connection is weak, click rerun test. If issues persist unplug router wait 20 seconds and plug it back in to see if that clears the issue.
- d. If there is no audio/video, trouble shoot the issue and allow the website permission in browser settings. (See Additional Instructions provided)

Validate your driver's license by taking pictures of the front and back. Hold the ID up until the camera focuses. Make sure pictures are not blurry or the validation will fail.



#### Step 11

Finally, Click on "Let's get started" and wait for your Remote Online Notary to join. During the signing if you experience any issues that you and the notary can not fix, utilize the chat feature within the site.
